FCCP Report: Children Opening to DCYF After Closure from the FCCP, FY 2018 Exit Cohort

The report below examines the percent of all Family Care Community Partnerships closures* and the number of children^ (unduplicated count) in FY 2018 who subsequently experienced a RI DCYF indicated investigation or removal (opened[&]) within 24 months of FCCP closure. Throughout this report, the number of children opening to DCYF from a 1-year exit cohort is quite small, meaning that examining trends over time may be more helpful with a larger cohort of children.

Among the 1,376 closures^{*}, 116 closures opened[&] to RI DCYF within 24 months of FCCP closure (Figure 1). Each 6-month time-point includes the previous period for a cumulative percent (i.e. 12 months are those that open between 0 and 12 months and includes the 59 that opened in the 6-month period). In comparison to the last reporting period, the overall number of children opening to the department after FCCP close has remained consistent, whereas the percentage has decreased, due to the number of children closing from the FCCP increasing.

Figure 2 examines the differences in opening[&] to DCYF within 24 months of FCCP closure* in children who consented to FCCP services (34%) and those who did not (66%). While the 6-month period opening and 12-month opening percentages are relatively similar, the two diverge at 18-months and 24-months. This suggests that consenting to FCCP services may have a more lasting effect on preventing opening to DCYF, than no intervention, over longer periods of time.

Tables 1, 2, 3 and 4 examine characteristics of children referred to the FCCP, and rates of opening to DCYF by characteristics of interest. Notably, in Table 2, children of color open at higher rates throughout the 24-month period, compared to White Non-Hispanic children. The trend is most disparate with Multiracial/Other Non-Hispanic children who cumulatively over 24-months open to DCYF 19% of the time. Table 4 examines the rates of opening to DCYF in a 24-month period across the different FCCP regions. While the rates of opening to DCYF differ between the regions, Washington/Kent has the greatest percentage of children opening to DCYF, which suggests a deeper look into regional differences of care and programing across the FCCP regions.
