

The number of children open to DCYF on the first day of the month by at-home and in out of home placement.




The number of children open to DCYF on the first day of the month in placement.



#### CPS: Number and Percentage of CPS Reports




Percent and Number of Screened in CPS reports received during the reporting month by response priority classification.



#### CPS: Percent of All CPS Reports Meeting DCYF Screen-In Policy



#### CPS: Percent of All CPS Investigations Meeting DCYF Response Time Policy





CPS: Percent of CPS Investigations Completed per Policy







### SRU: Number of Family Support Line Calls By Caller Source and Call Outcome, By Month






#### SRU: Number of Prevention Responses Opened by Source and Month



# The number of Prevention Responses that were opened by the Support and Response Unit from referral source.








#### SRU: Number of Prevention Responses Closed by Month




The number of children open to a Family Service Unit worker on the first day of the month by at-home vs in placement.





#### FSU: Average Number of Families Assigned to FSU Caseworkers






#### FSU: Percent of All FSU Youth with a Safety and Well-Being Visit Conducted







#### FSU: Percent of Mothers and Fathers Open to FSU who Received a Monthly Visit with Caseworker Statewide







#### FSU: Percent of Mothers and Fathers Open to FSU who Received a Monthly Visit with Caseworker By Region









#### FSU: Percent of All FSU Youth with an Active Service Plan








#### FSU: Percent of All FSU Youth with a Timely Service Plan Monthly












#### FSU: Percent of All FSU Youth with a Timely Service Plan Overall








#### Probation: Total Number of Youth on Probation Assigned to Assessment Unit and Transition Unit









#### Probation: Percent of Probation Youth with an Active Service Plan by Month






#### Probation: Number of All Probation Youth by Most Recent Risk Assessment





#### RITS: Number of All RITS Youth by Adjudication Status, by Month






# RITS: Number of RITS Youth by Adjudication Status and Gender, by Month








#### RITS: Number of RITS Youth by Most Recent Risk Assessment; Adjudicated and Non-Adjudicated





#### Out-of-Home Placement: Number and Percent of Children Placed in Foster Homes





### Out-of-Home Placement: Number of Children in Congregate Care by Placement Type






#### Out-of-Home Placement: Number of Children Entering, Discharging and Exit Destination Congregate Care Placements by Month






The total number of children who enter and exit from all combined congregate care types by month. A child may be counted more than once if the child had multiple entries and exits to and from congregate care. Exits and entries are counted when there is a break in the congregate care placements. For example, an exit from congregate care is counted if the child exits congregate care and went into a hospital, foster family, absent from care, RI Training School or returned home. When there are no breaks between congregate care placements (i.e., different congregate care providers) exits and entries are not counted as they have remained in congregate care. This data is reported on a delay to account for placement entries.





## Out-of-Home Placement: Number of Children in Medical Hospitals






Of all children in out-of-home placement on the first day of the month, how many were placed in psychiatric hospitals.





### Out-of-Home Placement: Number and Percent of Children Placed Out of State (Residential)



### Out-of-Home Placement: Number of Children Absent from Care



Common reasons include staying at a relative, partner, or friend's house. This chart does not reflect the length of time a child or youth has been absent, but rather is used for census purposes on the first day of each month. Children above could have been absent for as little as less than 1 day.





#### Out-of-Home Placement: Number of Children Entering Placement, Entering Supportive Reunification, and Discharging from All Placements





## Out-of-Home Placement: Children in Placement by Length of Time





#### Licensing: Newly Licensed Providers by Provider Type, by Month






#### Licensing: Number of Actively Licensed Homes and Utilization Percentage By Month








#### Licensing: Age of Children Served in DCYF Homes and Private Agency Homes, By Month








#### Licensing: Level of Need For Children Served by DCYF and Private Foster Agency Homes, By Month






