KEY FINDINGS

Collaboration, Communication, Inclusion and Workforce

- Enhancing cohesiveness among DCYF divisions and units improves overall outcomes for children, youth and families.
- Strengthened communication and collaboration initiatives contribute to better child well-being.
- Greater involvement of youth in their case planning is essential and genuine inclusion of family, youth, and provider perspectives is critical.
- Cultivating a supportive agency culture with a well-trained workforce that is supportive and respectful is crucial for team cohesion, maintaining casework integrity and building trust with youth and families.

RECOMMENDATIONS

- Increase access to therapeutic placement resources for children and youth.
- Ensure availability of language-appropriate resources for all families.
- Implement timely referrals and reduce waitlists for therapeutic resources.
- Provide trauma-focused resources for families and training for staff.
- Maintain consistent adherence to processes and policies across divisions.
- Simplify workflows and processes within each division for efficiency.

NEXT STEPS

Develop and maintain a five-year strategic plan with investment on Prevention, Accountability, Collaboration and Engagement.



CHILD WELLBEING ADVISORY COMMITTEE

DCYF seeks to strengthen the voices of staff, families, youth, and the community through the Child Well-being Advisory Committee (CWAC). This committee, made up of individuals with relevant experience, will work together to build on 2024 efforts and achieve the goals outlined in the strategic plan. Currently, DCYF gains insights from various groups, including Birth Parents, Resource Families, Kinship Families, and Youth Advisory Boards. While these groups function separately, there is a need for a more unified advisory committee to better align our strategies.
